ORDER

Sri. Alan Lukose and Smt. Parvathy S. Gopan have applied for Ph.D. registration in 2019 Admission under the Faculty of Commerce, vide the papers cited (5). The applications were rejected by the University on 20.09.2019 as the proposed research supervising teacher, Dr. P. N. Harikumar, Associate Professor and Research Supervising Teacher, Catholicate College, Pathanamthitta had no vacancies. The applicants, vide the paper cited (6), again submitted request for reconsidering the applications for research. The matter was placed before the University Research Committee held on 15.11.2019 and the same was rejected, vide the paper read as (7) above.

The Hon'ble High Court of Kerala, vide the paper read as (8) above, directed the University to permit the applicants to attend the Doctoral Interview scheduled on 25.11.2019 provisionally, subject to the result of the writ petition filed by Sri. Alan Lukose and Smt. Parvathy S. Gopan or any further orders to be passed by the Court. The applicants were permitted to attend the Doctoral Committee in compliance with this.

The Hon'ble High Court of Kerala, vide the paper read as (10) above, has also directed the University to register the names of Sri. Alan Lukose and Smt. Parvathy S. Gopan as research scholars before the cut off date subject to the final result of the writ petition or any further orders to be passed by the Court.

In compliance with the orders of the Hon'ble High Court of Kerala, as above, sanction has been accorded by the Vice-Chancellor, to Sri. Alan Lukose and Smt. Parvathy S. Gopan who were recommended by the

Doctoral Committee, vide the paper cited (9), being granted registration for research in Commerce, under the Faculty of Commerce, as shown below.
