As per the University Order cited (1), First, Second and Third one year each Extensions of the research period are being granted to research scholars considering their requests received with due recommendation of the research supervising teacher and head of the research centre concerned, and on payment of fee prescribed by the University from time to time. The first extension of research period is granted by the Vice-Chancellor and the Second and Third Extensions are granted by the Syndicate.

The University Research Committee held on 24.08.2020 discussed the matter of granting extensions of research period to the research scholars and resolved, vide the minutes read (2) above, to place before the Syndicate, its recommendation for considering the matter of granting the Second and Third Extensions also by the Vice Chancellor, in order to simplify and expedite the administrative process for issuing the extension orders.

Considering the above recommendation of the University Research Committee, the Syndicate has resolved, vide its minutes read (3) above, to delegate the powers of the Syndicate for granting the Second and Third Extensions of research period of Ph.D. scholars to the Vice-Chancellor.
