The Syndicate meeting held on 23.08.2022, vide read as (2) above, resolved to appoint Dr. A. Jose (Syndicate member) as Enquiry Commission to enquire into the matter in detail and to submit a report on research period allowable to the Research Scholars under the supervision of Retired/Adjunct/Deputation/Transferred supervising teachers, scholars in Self Financing colleges which are going to wind up by the University and scholars registered for Engineering subjects.

Vide read as (3) above, the Enquiry Commission put forward the following recommendation/(s) regarding the Research Period allowable to the above mentioned categories of research scholars;

 allow three Extension Periods (each of having duration one year) and three Grace Times (each of having duration six months) which the University now allow to the scholars after the completion of Normal Period of Research and need not allow further extension of research period. Based on the order of the Hon. Vice Chancellor on 17.11.2022, the Enquiry Commission Report was placed before the Syndicate.

The Syndicate meeting held on 23.12.2022, vide read as (4) above, resolved to approve and implement the Enquiry Commission Report. Moreover this report is only applicable till UGC Regulations, 2022 (Minimum Standards and Procedures for Award of Ph.D. Degree) come in to force.
