- The effective date of registration for all research scholars in Approved Research Centres, shall be the date of commencement of Course Work in the research centre.
- In the case of candidates eligible for Any Time Registration (CSIR UGC JRF/ KSCSTE JRF/ DST-INSPIRE etc.) the effective date of registration is the date of joining the research centre after obtaining the registration order.
- The registration granted will be confirmed only after the successful completion of the Course Work and on submission of all original documents related to research.
- The maximum and the minimum period of the research is as per Mahatma Gandhi University Regulations, 2016.
