The Chairmen and Subject Experts, including those who are invited from outside the jurisdiction of Mahatma Gandhi University, attending Doctoral Committee meeting for Ph.D. registration, are presently being paid Honorarium of Rs.1500/- (Rupees One Thousand Five Hundred only) and Rs.1000/- (Rupees One Thousand only) respectively for each session (two sessions a day - Forenoon & Afternoon), vide order read (1) above.

But, a daily sitting fee / consultation fee / honorarium was fixed for the Scientists / Experts / Teachers attending as invitees to the Academic / Research / Study related meetings from outside the institution, at the rate Rs. 4000/- (Rupees Four Thousand only) for Professors from different Universities, Heads of the different Central-State departments or that of equal designations and Rs. 3000/- (Rupees Three Thousand only) for other teachers who were not included in the above list, vide order read (2) above,

University Research Committee, vide minutes read (3) above, has resolved to recommend to grant honorarium of Rs. 2000/- (Rupees Two Thousand only) to the Chairman and Rs. 1500/- (Rupees One Thousand Five Hundred only) to the Subject Experts, the rate fixed [rate per day converted to rate per session ( Forenoon & Afternoon)] vide order read (2) above, and to extend the above rate [Rs. 2000/- (Rupees Two Thousand only) to Professors and Rs. 1500/- (Rupees One Thousand Five Hundred only) to other teachers] also applicable for the experts attending as invitees in the Research Advisory Committee / Pre-Ph.D. Presentation Committee etc.
