- The course work commences on 15th January 2024, for full time scholars vide ref.6, and 1st April 2024, for part time scholars (if it's a holiday, the next working day). In case of any change in the commencement of course work, the same will be intimated through the instructions for Ph. D Course Work, which will be issued shortly.
- The effective date of registration of the research scholars in University Department, irrespective of full time or part time, shall be the date of joining the research centre after obtaining the registration order.
- The effective date of registration for all research scholars in approved research centres, shall be the date of commencement of course work in the research centre.
- The registration granted will be confirmed only after the successful completion of the Course Work and on submission of all original documents related to research.
- The maximum and the minimum period of research is as per MGU Ph.D. Regulations 2016.
- The registration order is issued based on Mahatma Gandhi University Ph. D. Regulations, 2016. The registration procedures of the scholars of 2023 admission shall be governed by the University Grants Commission (Minimum Standards and Procedure for Award of Ph. D. Degree) Regulations, 2022, from the date of its implementation in the University.
