- The research scholars have to report to the research centre immediately after obtaining the registration order and shall undergo Course Work in the University Department / Approved Research Centre which commences on 15.01.2024 for Full time scholars and on 01.04.2024 for Part time scholars (if it is a holiday, on next working day) as per Mahatma Gandhi University Ph.D Course Work Guidelines 2016.
- The effective date of registration of the research scholars in University Departments, irrespective of full time or part time, shall be the date of joining the research centre after obtaining the registration order.
- The effective date of registration of the research scholars in Approved research centres, irrespective of full time or part time, shall be the date of commencement of course work in the research centre.
- For the Candidates eligible for Any Time Registration (CSIR/JRF/KSCSTE/INSPIRE etc.), the effective date of registration is be the date of joining the research centre after obtaining the registration order.
- The registration granted will be confirmed only after successful completion of Course Work and on submission of original documents related to research.
- The registration order is issued based on Mahatma Gandhi University Ph. D. Regulations, 2016. The registration procedures of the scholars of 2023 admission shall be governed by the University Grants Commission (Minimum Standards and Procedure for Award of Ph. D. Degree) Regulations, 2022, from the date of its implementation in the University (U.O. read (5) above).
