ORDER

- The research scholars have to report to the Research Centre after obtaining the registration order and shall attend the Course Work in the University Department/Approved Research Centre following the instructions of the University.
- **The course work commences on 01.04.2026 (if it is a holiday, the next working day) for full time & part time scholars as per the U.O. read (8) above.**
- The effective date of registration for all research scholars (Full Time & Part Time) shall be the date of joining at the research centre.
- In the case of candidates eligible for Any time registration, the effective date of registration shall be the date of joining the research centre.
- The provisional registration granted will be confirmed only after successful completion of Course Work.
- The Research Scholars should submit their original Qualifying certificate and Transfer Certificate to the Research Centre/Department at the time of joining as per U.O's read (6) & (7) above and Proper entries must be made by the Research Centre or Department in the admission register regarding this.
- Transfer Certificate of PhD Courses should be issued by the Centre or Department (in case of Cancellation of registration or after submission of Thesis) only after receiving the NOC from the University.
- **Joining report in the new format shall be submitted by the Head of the Department/ Principal of the Research Centre within ten days from the date of joining and it should be uploaded in the profile of the scholar in the research portal before sending the same to the university.**
- The maximum and the minimum period of research is as per MGU Ph.D. Regulations 2025.
